





IPO Valuation & Proceeds

- IPO Price: Rp390 per share
- Valuation: 9.7x PE Ratio
- IPO Proceeds: Rp404 billion
- Approximately 37% of the IPO proceed will be utilized to expand existing businesses, 13.75% will be used to fund new business expansions, and 49.25% will be used as working capital.
